DECISION

Central Institute for Supervising and Testing in agriculture, located at Hroznová 2, 603 00 Brno (hereinafter "ÚKZÚZ") as substantive competent authority within the meaning of § 2 article 1 letter e) Act. No. 147/2002 Coll., about Central Institute for Supervising and Testing in agriculture and on the amendment of some related acts (Act on the Central Institute for Supervising and Testing in agriculture), as amended, in proceedings regarding the registration of a plant biostimulant according to § 4 article 1 Act no. 156/1998 Coll., on fertilizers, auxiliary soil substances, plant biostimulants and substrates and on agrochemical testing of agricultural soils (Fertilizers Act), as amended,

decided as follows:

Based on the request of the legal entity ekolive **Germany GmbH**, **Humperdinckweg 12**, **Paderborn, 33102**, **Germany, VAT no.**: (hereinafter referred to as the "applicant") the **registration** of the plant biostimulant is granted as follows:

Name: microfertile™ carbon, plant biostimulant

Registration decision number: 5548

Validity period of the decision: 31.12.2027

Justification:

On **29.06.2022** reference no. **UKZUZ 124025/2022**, ÚKZÚZ received an application fro registration of the plant biostimulant **microfertile™ carbon**, **plant biostimulant**. In the course of the registration procedure, the applicant was informed of the conditions of registration, namely by attachment no. **UKZUZ 009019/2023**, which was delivered to him on 16.01.2023.

The participant in the proceedings did not comment within the specified period.

ÚKZÚZ warns the applicant that the approved wording of the label/package leaflet regarding the content of requirements according to § 7 article 1 letter e) of the Act on Fertilizers, i.e. warning signs and information for handling and instructions for the protection of human health and safety and for the protection of the environment, is subject of inspection by other state administration bodies competent under special regulations (in particular, the Czech Environmental Inspection under Act No. 350/2011 Coll., on chemical substances and chemical mixtures).

In conclusion, the ÚKZÚZ states that the applicant fulfilled all the conditions set by the Fertilizers Act for registration, and therefore administrative body registered the plant biostimulant with data as stated in the statement of this decision.

Instructions on appeal:

This decision can be appealed within fifteen days from the date of its notification to the Ministry of Agriculture of the Czech Republic, by submitting it to ÚKZÚZ, Oddělení hnojiv, Za Opravnou 4, 150 00 Praha. Any appeal to be filed will be decided by the Ministry of Agriculture, with the exception of possible self-remedial action by an administrative body. The deadline for filing an appeal is calculated from the day following the date of notification of this decision. Any appeal filed against the decision has a suspensory effect.
